ORDER PRELIMINARILY APPROVING SETTLEMENT WITH FORD CANADA

ORDER PRELIMINARILY APPROVING SETTLEMENT WITH FORD CANADA

Having read and considered Plaintiffs' motion for preliminary approval of settlement with Ford Motor Company of Canada, Limited ("Ford Canada") filed April 6, 2022 ("Motion"), and the Plaintiffs' supplemental filing made June 15, 2022, and having considered the oral argument presented to the Court on May 31, 2022, IT IS HEREBY ORDERED as follows:

- 1. All terms and definitions used herein have the same meaning as set forth in the Settlement Agreement ("Agreement" or "Settlement") attached as Exhibit A to the Declaration of Todd A. Seaver filed April 6, 2022.
- 2. The Settlement is within the range for which final approval may be granted, such that notice should be given to the Class. Furthermore, the Settlement appears to be the product of arm's-length and informed negotiations between experienced and knowledgeable counsel who have actively prosecuted and contested this litigation. The Settlement between Plaintiffs and Ford Canada is preliminarily approved.
- 3. The Class is defined as: All persons and entities residing in California on November 15, 2010, who purchased or leased a new motor vehicle manufactured or distributed by Ford Company; Ford Motor Company of Canada, Limited; Volvo Cars of North America LLC; Volvo Cars of Canada Ltd.; General Motors Corporation; General Motors of Canada, Ltd.; Saab Cars USA, Inc.; Saturn Corporation; DaimlerChrysler AG; DaimlerChrysler Corporation; DaimlerChrysler Motors Co., LLC; DaimlerChrysler Canada, Inc.; Toyota Motor Corporation; Toyota Motor Sales USA, Inc.; Toyota Canada, Inc; Honda Motor Company, Ltd.; American Honda Motor Company, Inc.; Honda Canada, Inc.; Nissan Motor Company, Ltd.; Nissan North America, Inc.; or Nissan Canada, Inc. from an Authorized Dealer located in California, during the period January 1, 2001 through April 30, 2003 for their own use."
- 4. "Class Escrow Counsel" is the law firm of Berman Tabacco.
- 5. The Court approves the proposed Notice Plan, attached as Exhibit 1 to the Supplemental Declaration of Eric Schachter of A.B. Data, Ltd. Regarding Notice Plan filed June 15, 2022 ("Supplemental Schachter Declaration"). The Notice Plan meets the requirements of due process and constitutes the best notice practicable under the

circumstances and constitutes valid, due, and sufficient notice to Class Members, complying fully with the requirements of Code of Civil Procedure § 382, California Rules of Court, rules 3.766 and 3.769, the California and United States Constitutions, and any other applicable law. The Court further approves the form of Postcard Notice/Short-Form Notice attached as Exhibit 2a to the Supplemental Schachter Declaration, the form of Long-Form Notice attached as Exhibit 3a to the Supplemental Schachter Declaration, the proposed digital advertisements attached as Exhibit 4 to the Supplemental Schachter Declaration, and the Claim Form in the form attached as Exhibit 5a to Supplemental Schachter Declaration. Notice of the Settlement shall be disseminated to the Class in accordance with the Notice Plan.

- 6. The Court approves the process for objecting to the Settlement and giving notice of intent to appear at the final approval hearing, as set forth in the approved Notice Plan and Long-Form Notice.
- 7. The Court appoints A.B. Data, Ltd. as the notice and claims administrator for the Settlement.
- 8. The hearing on Plaintiffs' motions for final approval and for fees, costs, and service awards is set for October 5, 2022, at 10:00 a.m., and the following schedule is set:
