JUDGMENT

This matter came before the Court on October 5, 2022, and October 21, 2022, pursuant to the Court's Order Preliminarily Approving Settlement with Ford Canada dated June 23, 2022, for a Final Approval Hearing on Plaintiffs' motion, on behalf of the Class, for final approval of the Settlement Agreement between Plaintiffs and Ford Motor Company of Canada, Limited ("Ford Canada").

The Court, being otherwise fully informed, and having made certain findings and determinations, and good cause appearing therefore, in its October 31, 2022 Order Granting Final Approval of Settlement With Ford Canada found that the Settlement Agreement is in all respects fair, reasonable, and adequate, and fully and finally approved the Settlement Agreement, including its payment and release provisions, and directed consummation of the Settlement Agreement according to its terms.

Accordingly, in light of the Order Granting Final Approval of Settlement With Ford Canada, the terms of which are hereby incorporated as if fully set forth herein, and good cause appearing, IT IS HEREBY ADJUDGED that:

- 1. This Judgment incorporates by reference the definitions in the Settlement Agreement, and all terms used herein shall have the same meanings set forth in the Settlement Agreement.¹
- 2. The Settlement Fund is \$82,000,000. Pursuant to the Court's October 26, 2022 Order Granting Plaintiffs' Motion for Award of Attorneys' Fees, Reimbursement of Expenses, and Payment of Services Awards, the following amounts shall be paid from the Settlement Fund:
 - i. Attorneys' fees in the amount of \$27,306,000;
 - ii. Litigation expenses in the amount of \$1,293.971.39;
 - iii. A \$5,000 service award to named Plaintiff Jason Gabelsberg; and
 - iv. A \$5,000 service award to named Plaintiff W. Scott Young.
- 3. The Settlement Fund, net of the Court-approved deductions in Paragraph 2 *supra*, shall be distributed pursuant to Paragraph 21 of the Settlement Agreement.

¹ The Settlement Agreement is attached as Exhibit A to the Declaration of Todd A. Seaver filed April 6, 2022.

- 4. Judgment shall be entered that Plaintiffs and the Class Members take nothing from Ford Canada other than as set forth in the Settlement Agreement and Order Granting Final Approval of the Settlement with Ford Canada, and that Plaintiffs and Class Members release all claims as set forth in Paragraph 11 of the Settlement Agreement.
- 5. As to Ford Canada, the Action be dismissed with prejudice and, except as provided for in this Agreement, without costs.
- 6. Without affecting the finality of this Judgment in any way, this Court hereby retains continuing jurisdiction over the Settlement and the Parties, consistent with California Code of Civil Procedure Section 664.6, and as provided in the Order Granting Final Approval of the Settlement, including with respect to: (a) implementation and consummation of the Settlement Agreement and any disputes relating to the Settlement Agreement, and (b) construing, enforcing, and administering the Settlement Agreement.
- 7. The Court determines that there is no just reason for delay and directs that this Judgment shall be entered.

IT IS SO ORDERED.
